RESTRICTED ITEMS/CONTRABAND

Items that present a safety risk or harm to clients. The following items are banned from client use due to safety concerns, health concerns, value and confidentiality issues.

- Any Items Restricted by Law
- Alcohol, Drugs and Drug Paraphernalia
- Weapons including Knives, Guns and Ammunition
- Matches, Lighters, Smoking Materials, Tobacco Products and Smokeless Tobacco products including E-Cigarettes
- Office/School Supplies Brought from Home (Supplies Will be provided by the Center for offered activities)
- Sharps and Needles of any kind including Scissors, Knives, Razors, Metal Nail files, Keys, Knitting Needles
- Inappropriate Clothing
 - Items with Advertisement of Drugs and Alcohol
 - Clothing that is Torn
 - Clothing that is revealing or imprinted with inappropriate messages on Drugs/Alcohol or disrespectful to others
 - Provocative/Revealing Clothing, Including but not Limited to: Hot Pants, Short Shorts, Tank Tops, Bathing Suits
- Pillows, Blankets, Stuffed Animal, Bedding, Towels, Sheets, etc.
- Electrical Items:
 - T.V's
 - Radio/ Stereo
 - Heating Pads, Electric Blankets/ Mattress Pads
 - Electrical Appliances
 - Clothing Irons/ Hair Irons/ Hair Straighteners
 - Vaporizer/Humidifier
- Cellular Phones, Smart Watches, Fit bit
- Laptops, Tablets
- Cameras or any other device that can capture picture, Video/Audio or go on the Internet
- Personal Hygiene/ Grooming items:
 - Talcum Powder/Baby Powder
 - Mouthwash or anything else with Alcohol Listed as an ingredient
 - Aerosol sprays/ Deodorant
 - Nail Polish Remover
 - Baby wipes/ Feminine wipes
 - Hair Clippers/Scissors
- Food or Beverages of any kind
- Candles or incense
- Inappropriate reading or viewing materials
- Purses, Bags, Luggage, Large Bags
- Guitar/Instrument Cases
- Medications (Prescription or Over the Counter) Including Vitamins/Health Shakes/Sport Drinks
- Sporting Equipment
- Laundry Detergent, Dryer Sheets (Pods are allowed)
- Credit Cards, Money and other Valuables – to be placed in Medical to be locked up.

SAFETY ITEMS

Items that present a potential safety risk to clients. The following items can be allowed for client use at the discretion of staff based on individual safety risk. Some items may need an order from a physician for use by the client.

- Electronics
 - Hair Dryers
 - Small Clock Radio
- Shaving Razors
- Only Small Beard Trimmers are allowed
- Jewelry will be assessed for safety by the Center
- Make-Up (limited quantities)
- Grooming and hygiene supplies
- Musical Instruments (at the discretion of staff)
- Physician ordered medical devices (must be used with medical staff only)

Any items not included on this list will be subject to staff discretion
